### **When was Eurobarometer project initiated?**

The Eurobarometer project was initiated in 1974 within the European Commission and was first conceived as a means to “reveal Europeans to themselves”. Since then, it has evolved and expanded significantly with different survey tools.

In 2007, the European Parliament started its own regular series of Eurobarometer surveys, focussing on topics specific to the European Parliament, including the European elections.

The combination of the wide range of topics covered consistently over a long time, the regularity of publications and geographical coverage makes the Eurobarometer a unique source of knowledge and information in the European Union

**EP (Parlamento Europeo) Autumn 2021 Survey: Defending Democracy | Empowering Citizens**

Defending the value of democracy should be the European Parliament's top priority, says the EP Autumn 2021 Eurobarometer (96.2). A third of respondents (32%) sees democracy as most important value to defend, followed by freedom of speech and thought (27%) and the protection of human rights (25%). In terms of policy priorities, citizens put public health first with 42%, followed by poverty and social exclusion (40%) as well as climate change (39%). The survey also shows the continued strong public support for the European Parliament, with 58% backing a more important role for Parliament in the future. The survey 96.2 was carried out by Kantar Public between 1 November and 2 December 2021 in all 27 EU Member States.

#### **Spring 2021 Survey**

A Special Eurobarometer survey conducted for the European Parliament between March and April 2021 shows the increasingly felt impact of the Covid-19 pandemic on citizens' personal lives and financial situation. As eight out of ten respondents are aware of the Union's actions to tackle the pandemic, public health, the fight against poverty and to restart the economy move to the top of citizens' priorities for the European Parliament. Overall, the EP Spring Eurobarometer confirms the robust support for the European Union throughout the pandemic - as well as the established broad consensus that global challenges such as the Covid-19 pandemic are best tackled at the EU level.

### **Parlemeter Survey 2020**

At the end of 2020, more respondents saw things on the right path at EU level in comparison with their own country. Furthermore, nearly three out of four respondents (72%) believe the EU Recovery Plan would allow their country's economy to recover more rapidly from the negative effects of the coronavirus pandemic. This survey finds an increase of ten percentage points in the number of citizens who expressed a positive view of the EU (50%) compared to autumn 2019. 66% of respondents in this survey are optimistic about the future of the European Union. Yet the individual outlook remains pessimistic in the face of the continuing pandemic: 53% of respondents believe that the economic situation in their country will be worse in one year's time than it is now.

91% of young Europeans (15–24-years old) agree that tackling climate change can help improve their own health and well-being, while 87% of all respondents also share this sentiment. 81% of respondents say they are happy living in the EU. 68% of Europeans agree the EU is a place of stability in a troubled world, while 67% agree the EU project offers a future perspective for Europe's youth. The Special EB517 "Future of Europe" was conducted as a joint survey by the European Commission and the European Parliament between 16 September and the 17 October 2021 in the 27 EU Member States.
